MAKES NO OTHER WARRANTY OR REPRESENTION, EXPRESS OR IMPLIED BY OPERATION OF LAW OR OTHERWISE, AS TO THE MERCHANTABILTY OR FITNESS FOR PARTICULAR PURPOSE OF ANY OF THE GOODS SOLD HEREUNDER, INCLUDING WITHOUT LIMITATION WARRANTIES ARISING FROM COURSE OF DEALING OR USAGE OF TRADE. Buyer acknowledges that Buyer alone has determined that the goods and services will meet the requirements of their intended use.

This warranty does not apply if the defective goods result from misuse, abuse, improper installation, alteration, accident, or negligence in use, storage, transportation, or handling, or due to unauthorized modification or damage resulting from interconnecting Gateway Industrial Products, Inc. goods with other goods not supplied by Gateway Industrial Products, Inc. The above limitations will apply whether the claim is pleaded in contract or in tort (including strict liability).
